

# PRINCE GEORGE’S COUNTY NOTICE OF A PROPOSED REAL PROPERTY TAX RATE INCREASE

For the taxable year beginning July 1, 2024, the County Council of Prince George’s County proposes to increase real property tax rates for the following municipalities as shown below:

Capitol Heights	from \$0.8800 per \$100 of assessment to \$0.8900 per \$100 of assessment.

Cottage City	from \$0.9180 per \$100 of assessment to \$0.9250 per \$100 of assessment.

Mount Rainier	from \$0.8700 per \$100 of assessment to \$0.8750 per \$100 of assessment.
New Carrollton	from \$0.8740 per \$100 of assessment to \$0.8780 per \$100 of assessment.
University Park	from \$0.8740 per \$100 of assessment to \$0.8780 per \$100 of assessment.
