



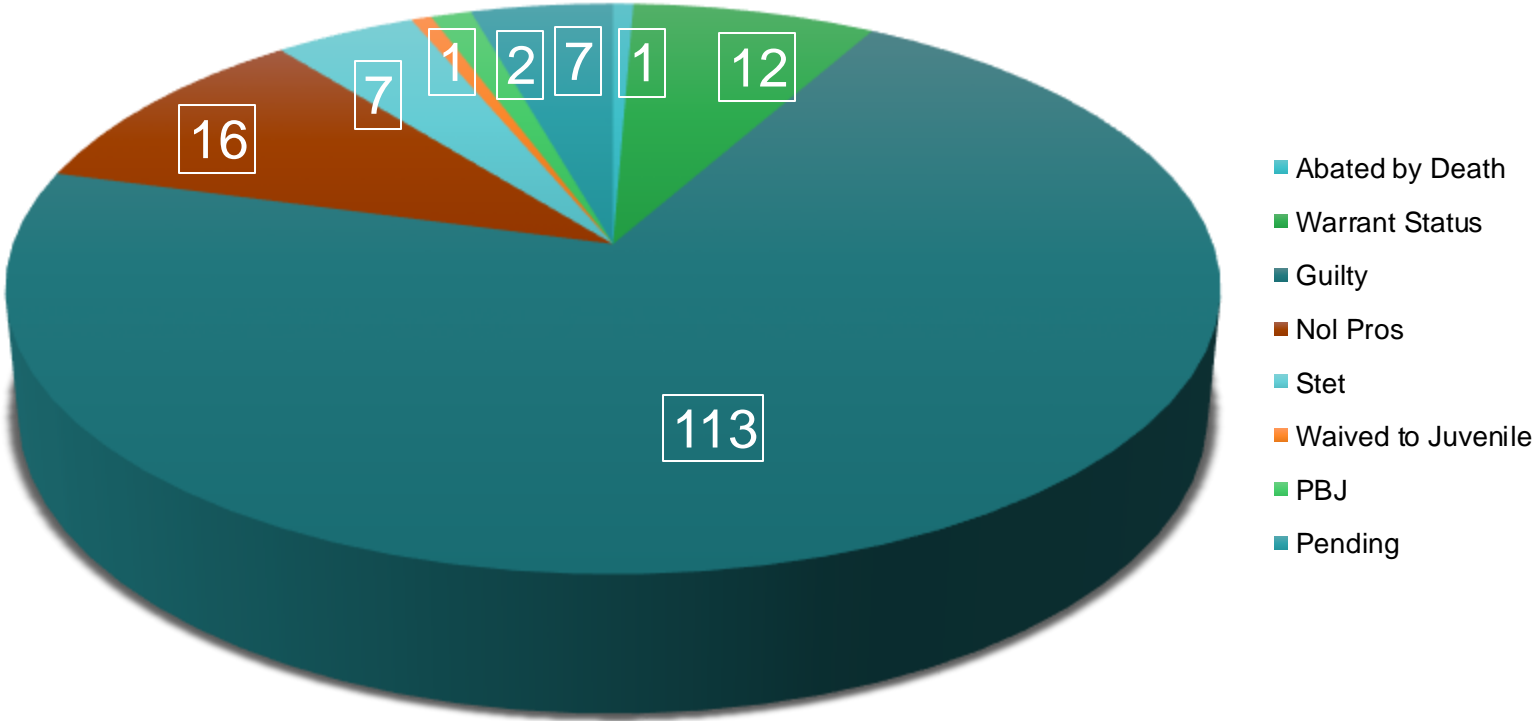
2024 PGSAO Gun Prosecution Case Stats & Dispositions



2024 Gun Possession Case Stats

From January 1, 2024-August 31, 2024, the State’s Attorney’s Office (PGSAO) has prosecuted 159 gun-possession cases. PGSAO has resolved approximately **88%** of its gun-possession cases.
