CB-098-2024 SHOPPING CART CONTROL

CB-098-2024 is an act concerning businesses and license – shopping cart control. After seeing shopping carts in yards, in the streets and on the side of major roadways, Council Member Fisher proposed the bill **CB-098-24** in order to keep shopping carts out of the communities and in their rightful places. Many stores will now be required to label their shopping carts and add some type of device that will aide in preventing shopping carts from leaving their rightful place.

DPIE – HB501/CB-090-2024

HB501 was passed during the 2024 General Assembly Session. This law authorizes local governments to increase penalties from \$1000 to \$5000. Amending the Code to reflect these new limits will assist in the enforcement of applicable County laws and regulations.

CB-090-2024 - AN ACT CONCERNING INCREASE OF GENERAL PENALTY for the purpose of increasing the penalty for prohibited acts or violations of the County Code from \$1000.00 to \$5000.00.

CR-63-2024: RESOLUTION TO ADVANCE P3 SCHOOL CONSTRUCTION



This was a critical resolution that paves the way for a brighter future for our children in Prince George's County. As a strong advocate for this resolution, I am proud to have fought for its approval, ensuring that we prioritize the educational needs of our young residents.

This resolution marks a significant milestone in our efforts to enhance the quality of education and infrastructure in our county. The multi-year Memorandum of Understanding (MOU) clearly defines the roles, rights, and responsibilities of the Board of Education of Prince George's County (PGCPS), the County, the Interagency Commission on School Construction (IAC), and the Maryland Stadium Authority (MSA) in funding and overseeing the Public-Private Partnership for the Design, Construction, Financing, and Maintenance of the County's Alternative Construction Financing Package, known as the Phase 2 Project.

By securing this resolution, we are not only investing in the physical infrastructure of our schools but also in the future of our children.
