We are pleased to submit the Eighth Compliance Report (the “Report”) in accordance with section 6.1 of the June 9, 2014 Community Benefit Agreement between MGM National Harbor and Prince George’s County (the “CBA”).

Scope of Report

The Report covers all activities undertaken by MGM National Harbor in the areas of Business Enterprise Utilization, Construction Business and Employment Opportunities during the Fourth Quarter of 2016 including October – December (“Covered Period”).

Certification of Obligations

We are pleased to report that as of December 8, 2016, our workforce of 3,741 rostered employees included 1,774 employees that were either Prince George’s County Residents or Veterans (47.4%). As a result, MGM has exceeded its goals for Operations Related Employment for year one (1) pursuant to Section 2.2 of the CBA on Day 1.


Methodology/Verification
