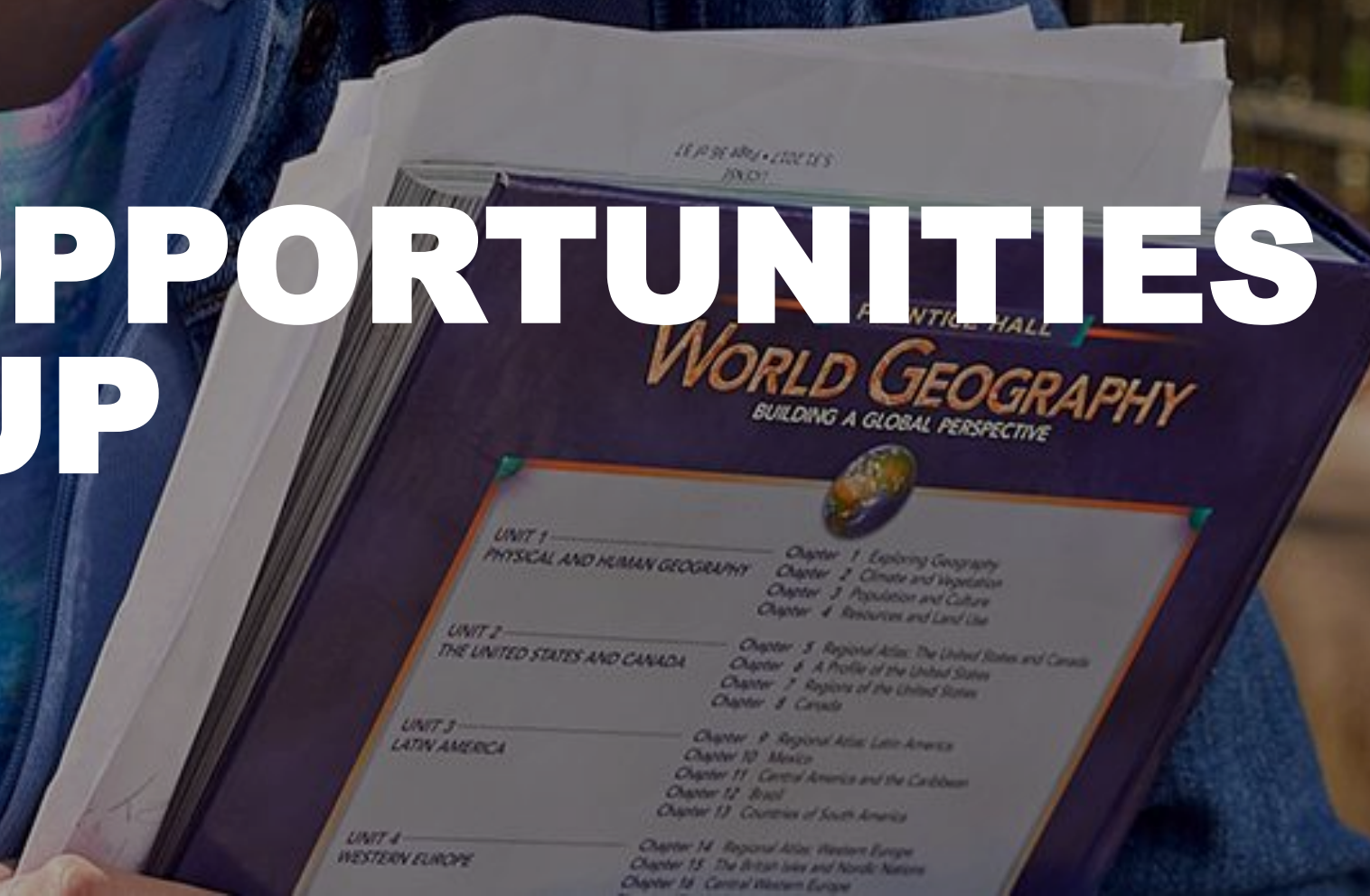

SUPPORTING RENTERS: POLICY AND INFORMATION & OUTREACH

WHAT WE HEARD

ACTIONS TO SUPPORT RENTERS:

- Emergency policies to prevent evictions (e.g., extended eviction moratorium; no-fault evictions bans; limits on lease termination; limits on filing hold over actions; grace periods to pay rent)
- Legal representation in eviction court (right to counsel; counsel to communicate on tenants' behalf)
- Formal lease requirement
- Rent control/limits on rent increases
- Authorization for tenants to use rent to fix unsanitary and unsafe conditions in apartments (after notice to landlord & waiting period)
- Rent forgiveness
- Sealed eviction records (like criminal record expungement)
- Creation of central place to assist tenants (Office of Tenant Advocate; landlord-tenant commission)

**Note that some policies may need to be enacted at the state level.*

EXPANDED TENANT RIGHTS MONTGOMERY COUNTY, MD

OBJECTIVE

Enhance tenant rights and protections.

KEY POLICY ELEMENTS

- **Standard Lease:** Requires 2-year lease term offer at start and renewal
- **Lease Termination:** Tenant can terminate lease (with 30 days notice) under defined circumstances beyond a tenant's control (domestic violence, senior living). Landlord must provide 60 days notice for lease termination.
- **Tenant Repairs:** If housing provider doesn't correct violation within a specified time (based on type of violation), DHCA Director may authorize resident to have violation corrected by licensed contractor from DHCA-maintained list and deduct cost of repair from rent (max: one month).

SUPPORTING RENTERS: TENANT POLICIES

FAIRNESS IN RENTING EMERGENCY AMENDMENT ACT WASHINGTON, DC

OBJECTIVE

Strengthen tenants' rights during the eviction process.

KEY POLICY ELEMENTS

- **More transparency:** Requires landlords to share criteria used to screen tenants for rental applications.
- **Eviction protections:** Prohibits evictions where the amount owed is less than \$600 or where the landlord lacks a business license. Authorizes the superior court to seal certain eviction records and requires the court to seal other records (3+ years or dismissed evictions).

APPLICABILITY TO PRINCE GEORGE'S COUNTY

- Barriers to renting

WHAT WE HEARD

ACTIONS TO SUPPORT RENTERS:

- One-stop shop (virtual citizen portal and 311 that provides information and self-help guidance)
- Outreach/education about available assistance (walking people through application process, pop-ups in central locations)
- Outreach/education about tenants' rights (including rent escrow & rental inspections)
- Counseling (renters and landlords)
- Tenant Bill of Rights (tenant protections)
- Central place to assist tenants (Office of Tenant Advocate; landlord-tenant commission)
- Rental housing liaison (to maintain relationships with tenant groups)
- Staff training on applicability of programs to residents without legal status

INFORMATION ATTRIBUTES:

- Easy to understand
- Available in multiple languages
- Available through trusted sources (community organizations & leaders; hyper local news sources)
- Offline options (radio, phone, etc.)

EXPANDED TENANT RIGHTS MONTGOMERY COUNTY, MD

OBJECTIVE

Inform tenants about increased apartment inspections and expanded tenant advocacy.

OUTREACH METHODS

- Door hangers, buses, bus shelters, County facilities, online communications via social media, electronic message boards
- Lobby signs posted in every multifamily apartment building (required by Amendment to Chapter 29, Landlord Tenant Relations of the Montgomery County, MD County Code)

APPLICABILITY TO PRINCE GEORGE'S COUNTY

- Cultural relevance
- Easy to understand information
- Targeted properties (properties defined as blighted with low complaints filed)

HOUSING MATTERS FORUM
