<a href="#">Art Works Studio School, Inc., dba Art Works Now</a>	\$2,000	Art Works Studio School, Inc., dba Art Works Now, will use grant funds to provide accessible, content-rich education through virtual programmatic efforts for Prince George's County residents of all age groups and abilities; and to provide free pizzas and art activities to essential workers and those experiencing food and income insecurity.
<a href="#">Beltsville Community Cats, Inc.</a>	\$3,000	Beltsville Community Cats (BCC) will use grant funds to expand TNVR efforts in Beltsville, including targeted TNYR in North Creek & Beltsville Heights, and to fund BCC's participation in the PG County Bail-Out Project.
<a href="#">Beltsville Seventh Day Adventist Church</a>	\$12,000	Beltsville Seventh Day Adventist Church will use grant funds to purchase and distribute 550 Thanksgiving Turkey Baskets to District One families.
<a href="#">B-Roll Media</a>	\$1,500	B-Roll Media will use grant funds to help support cost-free media arts education and training for underserved youth ages 13-21 and youth with diagnosed learning disabilities in Prince George's County, Maryland. More specifically, funds will help cover the costs of salaries / wages for instructors and for equipment.
<a href="#">Cherry Lane Boxing, Inc.</a>	\$4,000	Cherry Lane Boxing, Inc. will use grant funds for Nutrition (Food/Drinks, Gym Equipment, (Fitness Equipment/Gloves/Wraps, etc. and Mentorship (Speakers).
<a href="#">College Park Arts Exchange, Inc.</a>	\$1,500	College Park Arts Exchange will use grant funds to address physical and mental health needs during quarantine by providing free arts programming online, including weekly classes in Soul Line Dancing, Introduction to Tap, Draw Like an Artist, and Exploring Creative Writing.
<a href="#">Community Legal Services of Prince George's County</a>	\$3,000	Community Legal Services of Prince George's County will use grant funds to provide mobile legal services to reach out to underserved parts of the county lacking access to legal services, especially with regards to housing and consumer law matters which have increased due to the pandemic, but also including other civil legal matters.
<a href="#">Community Youth Advance</a>	\$2,500	Community Youth Advance will use grant funds to deliver year-round academic enrichment, mentoring, and college and career readiness activities that promote academic excellence, promote character and prepare youth to meet life's challenges.
<a href="#">Crosswood, Inc., dba The Pathway Schools</a>	\$2,000	Crosswood Inc. will use grant funds to provide arts-in-education residencies remotely for high school and middle school students with emotional and behavioral disabilities.
<a href="#">Eco Latinos, Inc.</a>	\$1,000	ecoLatinos will use grant funds for expenses related to hosting two COVID-19 vaccination clinics and a COVID-19-related environmental communications campaign called "River free of PPE / Rios Libres de PPE."
<a href="#">Engaged Community Offshoots, dba ECO City Farms</a>	\$1,000	Engaged Community Offshoots, dba ECO City Farms, will use grant funds for expenses related to safely and securely producing locally, healthy and affordable food. Funds will also be used to train people to provide essential sustenance in the future.
<a href="#">Fido's for Freedom, Inc.</a>	\$3,000	Fidos for Freedom will use grant funds to purchase a medication known as Dasuquin to be provided to service animals during training and after adoption in order to prevent injury and illness in the animals.
<a href="#">First Generation College Bound, Inc.</a>	\$5,000	First Generation College Bound will use grant funds for operating expenses related to their mission of inspiring low income and first- generation youth to achieve their social and economic success by providing advice, encouragement, and support to obtain a college degree.
<a href="#">Food &amp; Friends, Inc.</a>	\$3,000	Food & Friends will use grant funds to provide medically-tailored, home-delivered meals and groceries to individuals with serious illnesses such as HIV/AIDS and cancer that are too ill to buy or prepare food for themselves.
<a href="#">Hope Connections for Cancer Support</a>	\$2,500	Hope Connections for Cancer Support will use grant funds to help people with cancer and their loved ones deal with the social, emotional and physical impact of cancer through professionally-facilitated programs of emotional support, education, wellness and hope.
<a href="#">Laurel Advocacy Referral Services</a>	\$10,000	Laurel Advocacy Referral Services will use grant funds to cover part of the salaries of its case management team, which provides direct services to Prince George's County households in crisis.

<a href="#">Laurel Cats, Inc.</a>	\$3,000	Laurel Cats, Inc. will use funds to assist families from Prince George's County with the spay/neuter and other essential vet bills of their cats. Funds will also be used to spay/neuter and vet cats found on the streets of Prince George County before adoption.
<a href="#">Liberty's Promise, Inc.</a>	\$3,500	Liberty's Promise, Inc. will use grant funds to support their after-school program of civic engagement, held at Parkdale High School, twice annually, either in person or virtually, in 10 week sessions.
<a href="#">Mary's Center for Maternal and Child Care</a>	\$2,000	Mary's Center for Maternal and Child Care will use funds to continue providing crucial maternal health care to pregnant women at its Adelphi site in Prince George's County.
<a href="#">Meals on Wheels of the College Park Area</a>	\$3,000	Meals on Wheels of the College Park Area will use grant funds to purchase food items to assist in the preparation of meals for its clients and help maintain the price of the daily client contribution for service. Funds may also be used for paper products related to providing the daily meals.
<a href="#">NAMI Prince George's County, Inc.</a>	\$2,000	NAMI Prince George's County will use grant funds for expenses related to providing mental health support, education, advocacy and community outreach for county residents.
<a href="#">New Day Maryland, Inc.</a>	\$4,000	New Day Maryland will use grant funds used to qualify for the Maryland Department of Housing and Community Development Financing Program to acquire a house for vulnerable people and people experiencing homelessness in the Laurel City area of Prince George's County. With the upfront cost to qualify for the program we will be able to purchase a four-to-five-bedroom house.
<a href="#">Patrons for Peace Project, Inc.</a>	\$5,000	Patrons for Peace Project, Inc. will use grant funds to provide rental assistance until job secured, private specialized transportation to psychiatric in-patient facilities to assure compliance, monetary support for food until food stamps kick in, transportation to court & commissioner's office, assistance with cell phones, etc.
<a href="#">PFC Black Chamber of Commerce</a>	\$4,000	PFC Black Chamber of Commerce will use grant funds to provide very small businesses access to short-term funds to assist in surviving the COVID-19 crisis.
<a href="#">Prince George's Philharmonic</a>	\$1,000	Prince George's Philharmonic will use grant funds to support digital/virtual productions, including Educational Outreach efforts of the Philharmonic.
<a href="#">Side by Side, Inc.</a>	\$5,000	Side by Side will use grant funds to provide online workshops for parents of students at six partner elementary schools in Laurel and Beltsville.
<a href="#">The ARC of Prince George's County</a>	\$2,500	The ARC of Prince George's County will use grant funds to support programming that supports inclusion and independent living for individuals with Intellectual / Developmental Disabilities (I/DD) by preparing them for post-secondary education and employment, and delivering activities that build work / volunteer skills.
<a href="#">The Laurel Historical Society</a>	\$4,000	The Laurel Historical Society will use grant funds support the Laurel Museum's virtual educational programs and activities for children and adults.
