Bowie Citizens for Local Animal Welfare	\$1,000	Bowie Citizens for Local Animal Welfare will use grant funds to support their Community Cat Initiative which, through "trap/neuter/return" (TNR) is reducing the feral cat population in the Greater Bowie area, including Council Districts 3, 4, 5 and 6 as well as Glenn Dale, Glenridge, Landover Hills, Lanham and New Carrollton.
Buffalo Soldiers of Maryland Foundation	\$5,000	Buffalo Soldiers of Maryland Foundation will use grant funds to provide scholarship awards to Prince George County graduating seniors accepted into an accredited four year college or university.
Bursting with Promise, Inc.	\$5,000	Bursting with Promise will use grant funds to provide scholarships for qualified and deserving Maryland students entering Morgan State University.
Charles Drew Memorial Scholarship Fund (CDMSF)	\$20,000	Charles Drew Memorial Scholarship Fund will use grant funds for expenses related to providing scholarships to eligible Prince George's County High School graduates going to college and for conducting and mentoring Project Enrich Program.
E.V.O.L.V.E., Inc.	\$10,000	E.V.O.L.V.E., Inc. will use grant funds to support the planning and implementation of programs that provide stress management, mental health forums for high school students navigating uncertainty during a crisis, and (2) support salaries of healthcare professionals, and part-time admin assistant, & technology.
