The Charles Drew Memorial Scholarship Fund, Inc. (CDMSF)	\$10,000	The Charles Drew Memorial Scholarship Fund will use grant funds for expenses related to providing scholarships to eligible Prince George's County high school graduates going to college and for conducting the Project Enrich Program.
The Foundation for the Advancement of Music and Education, Inc. (FAME)	\$10,000	The Foundation for the Advancement of Music and Education (FAME) will use grant funds for expenses related to the Music Production Workshop and general operations for its Summer Music Program.
NAMI Prince George's County, MD, Inc.	\$10,000	NAMI Prince George's County, MD, Inc. will use grant funds to provide mental health education, support, advocacy, and community outreach programs for County residents.
First Baptist Church of District Heights, Inc.	\$10,000	First Baptist Church of District Heights will use grant funds for its pilot program, "The Heights Sneaker Fest," to purchase and distribute 400 pairs of sneakers to low- and moderate-income students attending District Heights Elementary School.
The Ivy Community Charities of Prince George's County, Inc.	\$7,500	The Ivy Community Charities of Prince George's County, Inc. will use grant funds to provide scholarships to students who are in or attend a school in Prince George's County as well as, continuing or returning scholarship to an aspiring college student.
Prince George's Arts and Humanities Council, Inc.	\$7,000	Prince George's Arts and Humanities Council will use grant funds to offset fund cuts to its signature grant program which supports artists, arts organizations and agencies throughout the County through Artist Fellowships, County Arts (organizations), Arts in Education and Public Art.
Community Ministry of Prince George's County, Maryland	\$7,000	Community Ministry of Prince George's County, Maryland will use grant funds to provide 150-250 COVID-19 affected applicants (mostly mothers and seniors) housing assistance consisting of consultations, referral services and small grants to avoid evictions.
End Time Harvest Ministries, Inc.	\$5,000	End Time Harvest Ministries will use grant funds to continue their ETHM's Pathway to Career Success program, which develops youth academically with a career and college preparation focus, including on-time graduation and preparation for college and workforce entry.
Food & Friends, Inc.	\$5,000	Food & Friends will use grant funds to provide home-delivered, medically-tailored meals and groceries to people living with serious illnesses like HIV, cancer, diabetes, COPD, end-stage renal disease, etc., whose illness prevents them from shopping for and preparing food for themselves.
Bishop McNamara High School, Inc.	\$5,000	Bishop McNamara High School, Inc. will use grant funds to assist families from Prince George's County with food and tuition assistance, which will allow students to continue their education uninterrupted.
Jacob's Ladder, Inc.	\$5,000	Jacob's Ladder, Inc. will use grant funds for their on going programs: Diversion, Juvenile Reentry, Junior Workforce Academy, Academic Enrichment, Teenpreneur Challenges and Community Awareness Events.
Coalition of Concerned Black Christian Men (CCBCM)	\$5,000	Coalition of Concerned Black Christian Men (CCBCM) will use grant funds to support its two major programs: providing annual scholarships to Prince George's County high school seniors and providing food and monetary donations to families in need that live in the county. Funds will also be used for CCBCM's COVID initiative. More specifically, this initiative provides supplemental assistance to Prince George's County residents impacted by COVID to help them with expenses for rent, food, utilities and medicine.
Prince Georges County Police Athletic League, Inc.	\$4,000	Prince Georges County Police Athletic League, Inc. will use grant funds to support their efforts in expanding their programs, provide organizational funding needed due to a lack of fundraising, due to COVID-19. Funds will also help them to establish new partnerships in the County to expand the number of youth they can receive.

Community Legal Services of Prince George's County, Inc.	\$3,000	Community Legal Services of Prince George's County will use grant funds to provide general legal services to reach out to under-served areas of the County lacking access to legal services, including its Pilot Jail program to assist inmates in the Prince George's County Detention Center and representation for survivors of domestic violence.
Arc of Prince George's County	\$2,500	Arc of Prince George's County will use grant funds to support their programming that assists youth with I/DD successfully transition from school to adulthood, and their Benefits Enrollment Center, which connects individuals to public benefits to which they are entitled.
Prince George's Philharmonic, Inc.	\$2,500	Prince George's Philharmonic, Inc. will use grant funds to support educational outreach efforts and rehearsal/concert venue rental fees.
Art Works Studio School, Inc.	\$1,500	Art Works Studio School, Inc. will use grant funds to provide accessible, content-rich arts education through in-person, hybrid and virtual programmatic efforts for Prince George's County residents of all ages.
