#### **Proposed Amendment to the Adopted FY 2022–2023 and FY 2023–2028 Maryland-National Capital Park and Planning Commission Operating and Capital Budgets (CB-055-2022)**

**PURPOSE OF PUBLIC HEARING:** To give interested persons the opportunity to provide public comment concerning the Proposed Amendment to the Approved Fiscal Year 2022–2023 and 2023–2028 Operating and Capital Budgets of the Maryland-National Capital Park and Planning Commission to: (a) authorize current fiscal year expenditures for the Commission's purchase of the Property, (b) authorize expenditure of funds to enable appropriate renovation of the Largo Headquarters, and (c) otherwise provide for completion of the Largo Headquarters.
