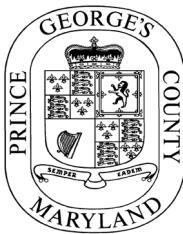

Notice is hereby given that on Tuesday, May 30, 2023, the County Council of Prince George's County, Maryland, will hold the following public hearing:

COUNCIL BILLS

CB-031-2023 (DR-2) – AN ORDINANCE CONCERNING CONVENIENCE STORES – GAS STATIONS – TOBACCO SHOPS – TOBACCO PRODUCT DISPLAY AND SALES AREA for the purpose of modifying the definitions of Convenience Store, Gas Station, and Tobacco Shop uses in the Zoning Ordinance to clarify the percentage of certain uses that may be dedicated to the display and sales of tobacco and cannabis-related products; and providing for a transition period to ensure compliance.

CB-039-2023 (DR 2) – AN ORDINANCE CONCERNING DEVELOPMENT REGULATIONS – NEIGHBORHOOD COMPATIBILITY STANDARDS – CENTRAL AVENUE CORRIDOR REDEVELOPMENT for the purpose of providing building height standards for development of property within the Central Avenue Corridor in proximity to single-family zones.

CB-040-2023 (DR 2) – AN ORDINANCE CONCERNING NONRESIDENTIAL BASE ZONES – INDUSTRIAL, EMPLOYMENT (IE) ZONE – INTENSITY AND DIMENSIONAL STANDARDS for the purpose of amending the lot coverage and green space requirements for development of property in the Industrial Employment (IE) Zone of Prince George's County.
